#### **SETTLEMENT AGREEMENT**

**WHEREAS** the above-named Parties have agreed to amicably settle their dispute at the Rivers State Multi-Door Courthouse (RSMDC), and resolved same as contained in this Settlement Agreement for endorsement as consent Judgement of the Small Claims Court of Rivers State.

#### **BACKGROUND**

- 1. The Applicant, Paulearnmore Int'l Ltd of Block 5032 International Market, SARS Road, Rukpokwu, Port Harcourt.
- 2. The Respondent, Alobari Augustina of No. 8 Wogboroma Street, Rumuokwuta Street, in Obio/Akpor Local Government Area of Rivers State.
- 3. The Applicant claims against the Respondent, the sum of N510,000.00k as the amount being owed to the Applicant.
- 4. The matter was referred by the Small Claims Court, Rumuodomaya to the Rivers State Multidoor Courthouse (RSMDC) for Alternative Dispute Resolution at no cost, based on the RSMDC Settlement Week 2025.

Upon the Mediation of the dispute, the Parties have agreed to a full and final settlement in the Terms stated below:

#### SETTLEMENT TERMS

The Parties have agreed that the Respondent shall pay to the Applicant the total sum	Ţ.

- 2. The Parties further agreed that the said money shall be paid in 10 installments of N50,000.00k monthly payment only for each installment as follows (edit accordingly):
- a. The amount owed shall be fully repaid by payment of N50,000 monthly until full repayment of the debt
- b. The Respondent shall commence payment of the agreed sum of N50,000 from the month of October, 2025 to the month of June, 2026 when the full and final payment of the debt sum of N510,000.00 shall be fully paid.
- 3. The Parties agree that this Settlement Agreement shall constitute the full and final settlement of this matter.
- The Parties agree that this Settlement Agreement shall be enforced in accordance with Section 21 (1) and (2) of the Rivers State Multi-Door Courthouse Law, No 9 of 2019.
