CONSOLIDATED CONSENT JUDGMENT

The Claimant claims against the Defendant as follows for RMC/SCC/10/2026;

1. An order that the defendant pays the claimant the sum of ~~N~~3,000,000.00 (Three Million Naira), being principal sums of loan and accrued interest not paid in the loan agreement of 30th June, 2025.
2. An order for damages of ~~N~~500,000.00 (Five Hundred Thousand Naira).
3. ~~N~~500,000.00 (Five Hundred Thousand Naira) as cost of litigation.
4. 10% annual interest of the total judgment sum.

FOR RMC/SCC/11/2026; The claimant claims as follows from the defendant;

1. An order that the defendant pays the claimant the sum of ~~N~~1,750,000.00 (One Million, Seven Hundred and Fifty Naira), being principal sums of loan and accrued interest in the loan agreement of 4th July, 2025.

2. An order for damages of ~~N~~300,000.00 (Three Hundred Thousand Naira).
3. ~~N~~300,000.00 (Three Hundred Thousand Naira) as cost of litigation.
4. 10% annual interest of the total judgment sum.

Facts

The claimant claims the sum of N1,000,000.00 from the defendants loaned to them on the 30th June, 2025 with an interest rate of 25% per month. Capital with accumulated interests not paid brings it to a total of N3,000,000.00 for **RMC/SCC/10/2026**.

Affidavit of service of the summons on the defendants before the Court dated 4th May, 2026 - Form RSSC 6.

For **RMC/SCC/11/2026**, the claimant claims, he loaned the defendants on the 4th July, 2025, the sum of N500,000.00 with an interest rate of 25% monthly, capital and accumulated interests not paid amount to N1,750,000.00, which the claimant claims from the defendants.

Damages, for RMC/SCC/11/26 at N300,000.00, damages for RMC/SCC/10/2026 N500,000.00

Cost of suit N300,000.00 and N500,000.00.

Annual interest of 10% of the total judgment sum.

Affidavit of service for RMC/SCC/11/2026 before the Court 4th May, 2026, personal service by the Court bailiff.

Both suits consolidated on the 8th May, 2026, upon the prayer of the claimant's counsel, E. U. Ikechukwu, Esq.

Leave granted for out of Court settlement on the 20th May, 2026, terms of settlement adopted by the claimant's counsel, E. U. Ikechukwu Esq dated 20th May, 2026, filed same day, executed by the claimant and the defendants, Jeff Emeka and Nnenka, Eze.

Terms of settlement as follows;

That the defendants shall pay to the claimant's bank account the sum of N4,500,000.00 (Four Million, Five Hundred Thousand Naira) in two installments as follows;

1. That the defendants shall pay to the claimant the sum of N2,250,000.00 (Two Million, Two Hundred and Fifty Naira) on or before 5th day of June, 2026.

2. That the defendants shall pay to the claimant the sum of N2,250,000.00 (Two Million, Two Hundred and Fifty Naira) on or before 5th day of July, 2026.
3. That there shall be no order as to cost to either party.
4. That the terms of settlement hereof is hereby adopted by the parties herein as the terms of judgment of this Honourable Court.

Wherefore the Court enters same as the Consent Judgment of the Court.
