ORDER NISI

Upon this matter coming up for hearing and determination before His Worship B.H. ABE (MRS) sitting at Chief Magistrate Court 1, Rumuodomaya, on Friday the 20th day of February, 2026, after hearing from the counsel to the Applicant, Agochi Amadi, Esq.;

THE COURT ORDERED AS FOLLOWS;

1. That an Order Nisi as in Form 26 of the Judgment (Enforcement) Rules is issued against all accounts of the Judgment Debtors in all or any of the branches of the above listed Garnishees for the payment of the Judgment sum of ₦900,000.00 (Nine Hundred Thousand Naira) only, pending when the Garnishees shall show cause why the Order Nisi shall not be made absolute.
2. That the 21st Garnishee attaches the account of the 1st Judgment Debtor with Account No: 8037736244 and any other account of the Judgment Debtor in its custody.
3. That the 22nd Garnishee attaches the account of the 1st Judgment Debtor with Account No: 8037736244 and any other account of the Judgment Debtor in its custody.
4. That the Judgment Debtors be served the Order Nisi in this suit through the 1st Judgment Debtor's WhatsApp number: 08037736244.
5. That the cost of N300,000.00 (Three Hundred Thousand Naira) only, be paid by the judgment debtors to the judgement creditor/applicant and not N500,000.00 (Five Hundred Thousand Naira) as prayed by the Applicant.
6. That the Garnishee Banks file and show the bank account(s) of the judgment debtors in their custodies for satisfaction of the said judgment sum and cost of this proceeding at N300,000.00 (Three Hundred Thousand Naira) only.
7. That a restriction be placed on the account of the judgment debtors pending the final determination of the Order Nisi.
8. That it is finally ordered, failure to appear in obedience to the Order Nisi will lead this Court to make the Order Nisi Absolute against any of the defaulting garnishee banks.
