RULING ON ORDER ABSOLUTE**Facts**


Agochi Amadi, Esq. appearing for the creditor, prayed the Court on the 24th April, 2026, to make the Order Nisi Absolute against the 8th Garnishee Bank, First Bank of Nigeria Limited, which has the sum of N94,193.41k (Ninety-Four Thousand, One Hundred and Ninety-Three Naira, Forty-One Kobo) belonging to the 1st Judgment Debtor, Engr. Nwachi John Otu.

Upon perusal of the bank statement attached to the affidavit to show cause filed by the 8th Garnishee Bank, First Bank of Nigeria Limited, belonging to the 1st judgment debtor, Nwachi John Otu, the Court is satisfied that the said sum of N94,193.41k (Ninety-Four Thousand, One Hundred and Ninety-Three Naira, Forty-One Kobo) is in possession of the 8th Garnishee Bank belong to the 1st judgment debtor.

Wherefore the Court in granting the prayer of the judgment creditor's counsel hereby orders as follows;

1. That an Order Absolute is made against the 8th Garnishee Bank, First Bank of Nigeria Limited.
 - a. In the sum of N94,000.00 (Ninety-Four Thousand Naira) only, standing creditor on the 1st judgment debtor's account with Account Number: 2003746271, Account Name: Nwachi John Otu, Bank; First Bank of Nigeria Limited in part satisfaction of the judgment debt.
 - b. That the said sum be paid to the judgment creditor's counsel with Account Name: Agochi Amadi, Esq. GTB; Account Number: 0261345341.
 - c. That this order be effected forthwith.
