TERMS OF SETTLEMENT

This **Terms of Settlement** dated this 3rd day of November, 2025 ("Terms of Settlement"), is made and entered into by the Claimant and Defendant to the Action constituted in SUIT NO. PMC/SCC/319/2024.

1. THE ACTION

By a complaint dated 19th day of November, 2024, the Claimant instituted this suit against the Defendant seeking the sum of ₦5,000,000.00 (Five Million Naira) only as his entitlement against the defendant which the defendant disputed the claim and challenged same.

2. NEGOTIATIONS FOR SETTLEMENT OUT OF COURT

Notwithstanding the claim of the Claimant and the denials by the Defendant, the parties sought the leave of the Court to attempt an act of court settlement of the dispute in the interest of peace and good neighborliness, which leave was graciously granted by the Court on the 16th day of September, 2025.

Consequent upon the grant of leave, series of meetings were called by the arbitrators which were duly attended by the parties and whereof the dispute was deliberated upon.

After much deliberations and discussion, with a view of finding an amicable settlement of the dispute, both parties have now reached an amicable settlement upon the terms set out hereunder.

3. TERMS OF SETTLEMENT

NOW, THEREFORE, IT IS HEREBY AGREED in the interest of peace as follows:

1. That the Claimant should be retired with full benefits.
2. That there shall be no order as to cost as the parties shall bear their respective cost.




