CONSENT JUDGMENT

The parties have settled amicably the claims in this suit and reduced the terms into writing. The terms of settlement has been signed by the parties and filed in Court on the 25th October, 2023.


Consent judgment is hereby entered for the parties as per their terms of settlement dated and filed on the 25th October, 2023 as follows:-

1. **IT IS ADJUDGED** that the 1st Defendant has agreed to pay and refund the sum of of ₦5,000,000.00 (Five Million Naira) only to the Claimant and the Claimant has agreed to receive the repayment of the sum hereinabove stated.

2. **IT IS ADJUDGED** that the 1st Defendant has undertaken and agreed to refund and repay the sum hereinabove stated in paragraph 1 as follows:

i) 1st repayment/installment of ₦2,000,000.00 (Two Million Naira) only shall be paid on or before the 30th day of Novmber, 2023.

ii) 2nd repayment/installment of ₦1,500,000.00 (One Million Five Hundred Thousand Naira) only shall be paid on or before the 31st day of December, 2023.

iii) 3rd repayment/installment of ₦1,500,000.00 (One Million, Five Hundred Thousand Naira) only shall be paid on or before the 31st day of January, 2024.

3. AND IT IS AGREED that the 1st Defendant shall make the refund and repayment to the Claimant in strict observance and adherence and in accordance with the stipulations set out in paragraph 2 above.

4. AND IT IS ADJUDGED that the terms and conditions herein shall constitute the full and final settlement of the claims against the Defendants.
