- i) 1^{st} repayment/installment of 12,000,000.00 (Two Million Naira) only shall be paid on or before the 30^{th} day of Novmber, 2023.

- 3. AND IT IS AGREED that the 1st Defendant shall make the refund and repayment to the Claimant in strict observance and adherance and in accordance with the stipulations set out in paragraph 2 above.
- 4. AND IT IS ADJUDGED that the terms and conditions herein shall constitute the full and final settlement of the claims against the Defendants.
