CONSENT JUDGMENT

UPON THIS MATTER coming up for hearing and determination in this Honourable Court before His Worship Nneka Eze-Obuzor Esq. Senior Magistrate sitting at Small Claims Court 4 Port Harcourt, and after hearing the application of F. O. Omosigho, Esq. for the claimant. Charles Ewuma Amakiri, Esq. for the 1st defendant. H. C. Nwachukwu, Esq. for the 2nd defendant. Uriem Callictus for the 1st and 3rd Defendants. E. E. Aimioshor-Ogbekhilu for the 4th defendant.

IT IS HEREBY ORDERED AS FOLLOWS:

1. That the 1st defendant shall pay the sum of Two Million Six Hundred and Eighty Thousand Naira (N2,680,000.00) only, to the claimant as claimed.
2. That the 1st defendant shall pay the sum of Two Hundred Thousand Naira (N200,000.00) only, as cost and or damages incurred by the claimant in the course of pursuing and prosecution this case.
3. That the 1st Defendant shall pay the sum of Five Hundred Thousand Naira (N500,000.00) only, on or before the 31st day of December, 2023 as first installment.
4. That the 1st Defendant shall fully pay the remaining sum of Two Million Three Hundred and Eighty Thousand Naira (N2,380,000.00) only, to the claimant on or before the 31st day of March, 2024.

5. That it is further agreed that the 1st defendant shall make installmental payment as per the remaining sum of Two Million, Three Hundred and Eighty Thousand Naira (N2,380,000.00) only within the three (3) months period herein agreed which is from the 1st day of January, 2024 to the 31st day of March, 2024, provided further that the entire sum herein agreed is fully paid by the 1st Defendant on or before the 31st day of March, 2024.
6. That the parties urge this Honourable Court to enter this terms of settlement as consent judgment between the claimant and the defendants.
