CONSENT JUDGMENT

UPON THIS MATTER coming up for hearing and determination in this Honourable Court before His Worship Nneka Eze-Obuzor Esq. Senior Magistrate sitting at Senior Magistrate Court 4 Port Harcourt, and after hearing the application of J. O. John, Esq. for the claimant, J. C. Egbugbu, Esq. for defendant holding brief of N. D. Okeah Esq.

IT IS HEREBY ORDERED AS FOLLOWS:

- 1. That these terms of settlement were voluntary and parties accept them as binding to end the dispute between them.
- 2. The parties agree to abandon claims of the claimant and have settled for a total and/or final sum of N2,497,000.00 (Two Million, Four Hundred and Ninety Seven Thousand Naira) to cover the entire claim.
- The defendant shall pay the total sum of N2,497,000.00 (Two Million, Four Hundred and Ninety Seven Thousand Naira) to the claimant as final settlement of the entire claim.
- 4. That the said sum may be paid once or on such installments not lower than N624,250.00 (Six Hundred and Twenty Four Thousand Two Hundred and Fifty Naira) every month into the claimant's counsel WEMA BANK account number 0242566379 of Julius Ogbonna John and it is provided



always that a total sum of N2,497,000.00 (Two Million, Four Hundred and Ninety Seven Thousand Naira) will completely paid into the said bank account not later than four (4) months commencing from the date of judgment in this suit.

- 5. That the defendant shall intensify effort to raise the funds to pay the total sum of N2,497,000.00 (Two Million, Four Hundred and Ninety Seven Thousand Naira) to the claimant.
- That the claimant is entitled to explore the necessary legal means and/or avenues to enforce the content of these terms of settlement including criminal prosecution upon the failure of the defendant to comply as herein agreed.
