CONSENT JUDGEMENT

UPON THIS MATTER coming up for Judgement and final determination before His Worship Nneka Eze-Obuzor Esq. Senior Magistrate Gd. II sitting at Small Claims Court 4, Port Harcourt. and after hearing the submission of V. G. Uzochukwu, Esq. for Claimant and R. C. Enyidah, Esq. for the Defendant.

IT IS HEREBY ORDERED AS FOLLOWS:-

1. That the Claimant herein agrees to accept the sum of N800,000.00 (Eight Hundred Thousand Naira) as full and final payment of the debt owe to it by the Defendant.
2. That the Defendant shall pay the cost of N150,000.00 (One Hundred and Fifty Thousand Naira) only, as cost of litigation in favour of the Claimant.
3. That the Defendant had already paid the sum of N400,000.00 (Four Hundred Thousand Naira) only, through his counsel R. C. Enyidah, Esq. to the Claimant's Counsel, Uzochukwu Victor Uzochukwu, Esq. receipt whereof the Claimant acknowledges on the 13<sup>th</sup> and 23<sup>rd</sup> day of November, 2023 respectively.
4. That the balance of N550,000.00 (Five Hundred and Fifty Thousand Naira) only shall be paid in two (2) installments of N250,000.00 (Two Hundred and Fifty Thousand Naira) only, in the month of December, 2023 and finally N300,000.00 (Three Hundred Thousand Naira) in the month of January, 2024.
